## **Closed Down/Attempts to Close Down Political Parties and Associations**

13 (The court case against Emekli-Sen "Retired-Union", which launched in 2002, was re-tried and it was closed down. Barış Gönülleri Derneği'-Association of Peace Volunteers- was dissolved. Court cases to close down against İHD (Human Rights Association) Branch in Mersin, Democratic Society Party (DTP), İlmi ve Kültürel Araştırmalar Vakfı (the Foundation of Scientific and Cultural Researches) and Lambdaİstanbul Derneği (Gay Association). The decision to close down of Ergani Pelda Women Association was quashed by the Supreme Court of Appeals. In accordance with the decision ECtHR; the cases of Halkin Emek Partisi (HEP)-People's Labour Party-, Özgürlük ve Demokrasi Partisi (ÖZDEP)-Freedom and Democracy Partyand Türkiye Birleşik Komünist Partisi'nin (TBKP)-United Communist Party of Turkey- will be retried.

Cases Concluded in 2007	In 5 concluded cases; 111 people were sentenced to 170 years and 3 months imprisonment and 9879 YTL fine in total. 12 people were acquitted. Cases against 49 people were dropped.
